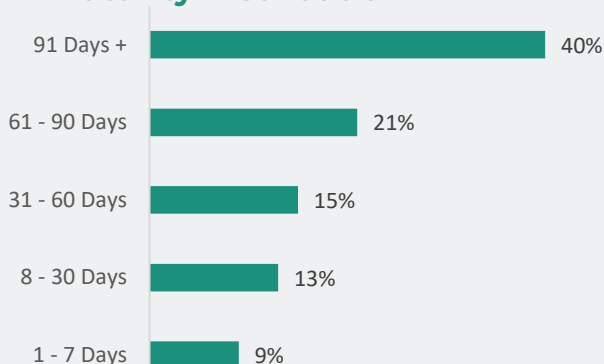

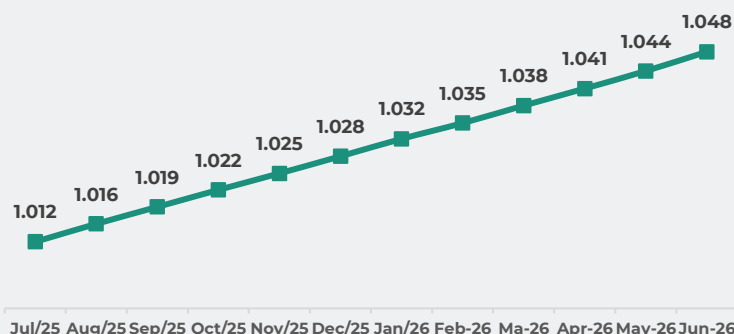
FUND OBJECTIVE AND STRATEGY

The Lulwa KD Money Market Fund is an open-ended, Sharia-compliant fund established in Kuwait, regulated and licensed by the Capital Markets Authority of Kuwait under license number LCIS/2025/0001. The fund offers investors exposure to the money market, focusing on maximizing income while safeguarding capital and ensuring liquidity. It achieves this by investing in low-risk, highly liquid, short-term instruments compliant with Sharia principles, such as bank deposits and Sukuk. This strategy helps investors effectively utilize excess cash while potentially earning returns higher than standard deposit rates.
